

The Corporation of the Municipality of West Grey

By-law Number 60 - 2015

Being, a by-law to regulate the placement of signage in proximity to Municipality of West Grey Entrance Way Signs;

Whereas, Section 11 (2) of the Municipal Act 2001, S.O. 2001, c.25, as amended, provides that the Council of a Municipality may pass By-laws under the "Structures, including Fences and Signs" sphere of jurisdiction;

And whereas, Section 99 of the Municipal Act 2001, S.O. 2001, c.25, as amended establishes rules which apply to a by-law of a Municipality respecting advertising devices, including signs;

And whereas, the Provincial Offences Act, R.S.O. 1990, c.p.33, s.61 provides a penalty for persons who contravene any of the provisions of a municipal by-law;

And whereas, Council of the Municipality of West Grey deems it expedient to establish a By-law to regulate the placement of signage in proximity to Municipality of West Grey Entrance Way Signs;

Now therefore the Council of the Corporation of the Municipality of West Grey hereby enacts as follows:

1. This By-law may be cited as "The Municipal Entrance Way Sign By-law".
2. No person shall erect, enlarge or place a sign or its structure, whether temporary or permanent, within 7.6 metres of any Municipality of West Grey Entrance Way Signs, unless previously approved by the Municipality of West Grey Director of Infrastructure and Public Works, or his/her delegate.
3. Every owner/organization responsible for the sign shall immediately remove it after the conclusion of the event listed on the sign, and if not removed, shall be removed forthwith by the Municipality of West Grey, and the penalty provisions contained in section 5 of this by-law shall apply.
4. This By-law shall be administered and enforced by the Chief Building Official, By-law Enforcement Officer, Police Officer, or other person appointed by the Municipality of West Grey.
5. Every person who contravenes this By-law is guilty of an offence and on conviction is liable to a fine as provided for in the Provincial Offences Act, R.S.O. 1990 c.P.33, as amended or re-enacted from time to time.
6. For purposes of this By-law, each and every day that a contravention of this By-law continues constitutes a separate and distinct offence under this By-law.
7. That Schedule "A" attached hereto forms part of this By-law
8. This By-law shall come into full force and effect upon receiving the final passing thereof.

Read a third time and finally passed this 9th day of September, 2015.
