

Notice of Nomination for Office 2022 Municipal and School Board Elections



Candidate Nomination & Third Party Advertiser Registration

For the municipalities of:

The Town of Hanover and The Municipality of West Grey

This notice is for anyone proposing to be a candidate, or register as a third party advertiser, for the 2022 Municipal and School Board Elections on October 24, 2022 within the Town of Hanover or the Municipality of West Grey.

Candidates for Municipal Council and School Board Trustee positions may file a nomination form during regular business hours beginning Monday, May 2, 2022, with the last day and time for filing being Friday, August 19, 2022, at 2:00 p.m.

A prescribed fee in the amount of \$200.00 for Head of Council and \$100.00 for all other candidates payable by cash, debit, certified cheque or money order must accompany the nomination form. Each municipal candidate must file the prescribed form with 25 signatures endorsing their nomination (school board candidates are exempt).

Candidates must not spend or raise any funds for their election campaign until the nomination form has been filed.

Nominations may be filed for the following municipal offices:

- Mayor One, to be elected at large.
- **Deputy Mayor** One, to be elected at large.
- Councillor Five, to be elected at large.

Candidates may also file a nomination for School Board Trustee for one of the following District School Boards:

- Bruce-Grey Catholic District School Board One trustee to be elected from the combined municipalities of Grey Highlands, Hanover, Southgate and West Grey. (Nominations for this office may be filed at the office of the Hanover Clerk.)
- Bluewater District School Board One trustee to be elected from the combined municipalities of Hanover and West Grey. (Nominations for this office may be filed at the office of the West Grey Clerk.)
- Conseil scolaire Viamonde (French Public School Board) One trustee to be elected from the combined area of all the municipalities located within the Counties of Bruce, Grey, Dufferin and Simcoe. (Nominations for this office may be filed at the office of the Barrie City Clerk at 70 Collier Street, Barrie, Ontario or upon request, at the Municipal Clerk's Office in your municipality if the distance between your residence and the Barrie City Hall is greater than 100 kilometres.)
- Conseil scolaire Catholique Providence (French Separate School Board) One trustee to be elected from the combined area of all the municipalities located within the Counties of Grey, Bruce, Huron, Perth and Lambton. (Nominations for this office may be filed at the office of the Sarnia City Clerk at 255 Christina Street North, Sarnia, Ontario or upon request, at the Municipal Clerk's Office in your municipality if the distance between your residence and the Sarnia City Hall is greater than 100 kilometres.)

The above offices are for a 4-year term. Candidates are required to submit nominations on the prescribed forms only.

A third party advertiser is any individual, corporation or trade union that causes an election campaign advertisement to appear. Third party advertisers are required to register with the Clerk of the municipality where they want to advertise. Registrations of third party advertisers will be accepted between Monday, May 2, 2022 and Friday, October 21, 2022. A third party advertiser may not spend money on their campaign, accept contributions or begin advertising until the Clerk certifies the registration.

All forms may be obtained from the office of the Municipal Clerk during normal office hours.
